105/22 Apologies for absence

Received from Councillor Karen James. Councillor Tim Koetser was absent.

106/22 Declarations of interest

107/22 Planning

22/01874/FULLS Mornington, North Lane West Tytherley SP1 1LX

PROPOSAL: Demolition of two agricultural buildings, erection of two detached dwellings with associated parking for six vehicles, access and soft landscaping.

JC explained that the Parish Council had expressed several concerns regarding the applicant's previous proposal for this property (21/02789/FULLS). This application was subsequently withdrawn.

JC had met with the applicants to discuss the concerns of the Parish Council. The applicants have addressed these concerns within the revised plans submitted in this application. The proposed roof heights of both dwellings have been reduced substantially, the dwellings will be single-storey (instead of two-storey) thus becoming more in keeping with the environment, the proposed footprints of each of the dwellings have been reduced to be close to that of the existing barns, the access to and from North Lane (already constructed) has been improved and the concerns raised by a neighbour have been addressed. There were no concerns expressed regarding trees and the environment.

The Parish Council wish to convey it's appreciation to the applicants for listening to and accommodating the concerns of the Parish Council.

A vote was taken:

It was agreed unanimously to support the application, subject to the approval of Hampshire County Council Highways Department regarding the access to and from North Lane. Therefore a "No Objection" response will be submitted.

22/01906/FULLS 27 Hillside Close, West Dean SP5 1EX

PROPOSAL: Build a single-storey side extension to contain a bedroom and a toilet.

JC stated that the proposal is to replace an existing extension with a substantive extension.

The application was within guidelines, with no concerns regarding overlooking or the environment and no change to access to the property. Neighbouring properties already have similar extensions built.

A vote was taken:

It was unanimously agreed to support the proposal, therefore a "Support" response will be submitted.
