## West Tytherley Parish Council Co-option Eligibility Form

Persons applying for the role of Parish Councillor at application date must:

- 1) Be a British subject or a citizen of the Commonwealth or European Union
- 2) Be 18 years of age or over and
- 3) Be able to meet at least one of the following qualifications (please tick **all** that apply to you):
  - ..... i) I am and have been registered as a local government elector for the Parish;
  - ..... ii) During the whole of the twelve months preceding the date of application I have occupied, as owner or tenant, land or premises in the Parish;
  - ..... iii) I have had a principal or only place of work during the preceding twelve months in the Parish;
  - ..... iv) I have resided within the Parish during the whole preceding twelve months or within 3 miles of its boundary;
- 4) Not be disqualified from being a member of a Local Council under the Local Government Act 1972. A person is disqualified if they:
  - Hold any paid office or employment of the local council or joint committee on which the Council is represented **or**
  - Is a person who has been adjudged bankrupt or has made a composition or arrangement with creditors **or**
  - Has within five years before the date of this application been convicted in the UK, Channel Islands or Isle of Man of any offence and has been sentenced to imprisonment or not less than three months without the option of a fine **or**
  - Is otherwise disqualified under Part 111 of the representation of the People Act 1983 for corrupt or illegal practices.

(Note: Disqualification for bankruptcy ceases in the following circumstances:

\*if the bankruptcy is annulled on the grounds that either the person ought not to have been adjudged bankrupt, or that their debts have been fully discharged

\*if the person is discharged with a certificate that the bankruptcy was caused by misfortune without misconduct on their part

\*if the person is discharged without such a certificate).
